THE RULE REQUIRES AMONG OTHER THINGS, THAT ALL RENOVATION ACTIVITIES BE PERFORMED AND DIRECTED BY AN INDIVIDUAL WHO HAS BECOME CERTIFIED BY SUCCESSFULLY COMPLETING RENOVATOR TRAINING FROM AN ACCREDITED TRAINING PROVIDER

THOSE TRADES THAT MAY BE SUBJECT TO THE LRRPP RULE INCLUDING, BUT NOT LIMITED TO: BUILDING MATERIALS (ROOFING, SIDING, GUTTERS, DECKING) , MILLWORK, WINDOWS, STORM DOORS, RETRACTABLE SCREEN DOORS AND GARAGE DOORS, BLINDS, SHUTTERS, FLOORING, CABINETS, COUNTERTOPS, BATH VANITIES.
